  - A. Bills for Discussion: **New and/or Amended**
    1. **AB 12 (Beale)** **Revises** the current “Kinship Guardianship Assistance Payment Program (Kin-GAP), which (as) a part of the CalWORKs program
    2. **AB 89 (Torlakson)** Creates new tobacco tax used exclusively for education, children's health care, tobacco cessation services and lung cancer research.
    3. **AB 304 (Price)** – Amended 4/16; requires APPs to establish a program of electronic banking for payments made to licensed or license-exempt family day care homes; implementate within one year.
    4. **AB 315 (De Leon)** – requires CDE to adopt specific regulations related to APPs
    5. **AB 434 (Block)** Reduces Prop. 49 local match for afterschool programs
    6. **AB 495 (Davis)** Gutted & Amended 5/13 - **By 1-1-11. CDE shall post at least statewide & county-level data on availability and need for child care and child development programs for infants, toddlers, and preschoolers on Data Quest, and update it every two years. They have to do this in any system that replaces Data Quest.**
    7. **AB 595 (Adams)** Would prohibit DSS from issuing a license to any foster family home or certified family home applicant who has not obtained both a California and Federal Bureau of Investigation criminal record clearance or an exemption
    8. **AB 627 (Brownlee)** Adds new nutrition requirements for licensed child care facilities
    9. **AB 769 (Torres)** State preschool priority- Adds “children who have a biological parent who is, or who has been within the previous 6 months, **“a dependent or ward of the juvenile court”** as a priority for state preschool equivalent to CPS referral. **5-13 amendment specifies it applies to dependents or wards of the court under Section 300, 601, or 602 of the Welfare and Institutions Code.**
    10. **AB 932 (Torlakson)** Child care facilities fund
    11. **AB 983 (Skinner)** Would allow Prop 49 after school programs to operate on weekends
    12. **AB 997 (Krekorian)** Requires coordination between DSS & DDA to generate information identifying all sex offenders living in licensed residential, child care, or foster care facilities.
    13. **AB 1124 (Yamada)** Continuity of services for children aging out of CEISA programs.
    14. **AB 1349 (Torlakson)** Funding for Prop 49 after-school programs - **Suspense**
    15. **SB 244 (Wright)** Early Learning and Development support Act – priority enrollment for “at risk” children **Amended**
    16. **SB 379 (Huff)** Exempts Heritage schools from child care licensure
